## 1. **Settlement at Savage** – Susan Garber

A petition requesting that Patuxent River Commission be allowed to comment on development issues affecting the Patuxent River were sent to the Maryland DNR and NPS. 485 people thus far have signed the petition.

# 2. NT and 50th Anniversary Movie – Brian England

### 3. Member Speak Out – Chris Alleva

It was reported the County is leasing space in the Lakeview Building. It could be considered a conflict of interest as the County is reviewing plans to build the buildings parking lot.

# 4. **Meeting with County Executive** – Stu Kohn

Reported he met with County Executive Kittleman and DPZ with Dan O'Leary and Ted Mariani from the Greater Highland Crossroads Association and Concerned Citizens of Howard County respectively to discuss concerns related to the Planned Service Area expansion on Rt 108 for the Erickson proposal. In addition, discussion occurred as to whether the Council should have even been allowed to vote on the PSA expansion under 16.211because the vote was after the Primary. The impact of the "whereas" clause was also discussed. We are very disappointed in the Office of Law decision in the aforementioned issues.

### 5. New Court House -- Susan Garber

Concerns about spending \$459 million on a court house were expressed. Also, the relocation of many displaced HC Departments.

#### 6. Ellicott City Flood Mitigation -- Lisa Markovitz

Support for the Plan was discussed and there was a difference of opinion so it was agreed that the board should not take a position to testify on 17 September at the next Public Legislative Hearing. It will be up to individuals Board members to testify if they choose.

# 7. **Metroplex BWI Roundtable --** Paul Verchinski

The last meeting was held and the Roundtable agreed to concentrate their efforts on MAA. They will have quarterly meetings.
